Dear Licensee:

Down Home Broadcasting ("Down Home") is hereby notified of the modification of License BLH-19901120KC for WYVC(FM), Camden, Alabama to specify Channel 230A.

On January 22, 2007, The Opp Broadcasting Co., Inc. ("Opp"), filed a minor change application (BPH-20070122AIT)¹ requesting the substitution of Channel 230A for Channel 272A at Camden, Alabama and the modification of the above captioned license.² Section 316(a) of the Communications Act of 1934, as amended,³ permits us to modify the license or construction permit if such action is in the public interest. The Act requires that we notify the affected station of the proposed action, the public interest reasons for the action, and afford at least 30 days to respond. Accordingly, by staff letter dated June 26, 2007, Down Home was directed to show cause why its license should not be modified to specify Channel 230A in lieu of Channel 272A. By letter dated July 25, 2007 Down Home requested an extension until August 24, 2007 in which to respond to this letter. As of this date, no further response from Down Home has been received.

Accordingly, pursuant to the authority found in 47 U.S.C. Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) and 47 C.F.R. Sections 0.61, 0.204(b) and 0.283, IT IS ORDERED, That effective the date of this letter, the FM assignment IS MODIFIED as follows:

Add 230A, Delete 272A

Pursuant to Section 316(a) of the Communications Act of 1934, as amended, License BLH-19901120KC IS MODIFIED to specify operation on Channel 230A in lieu of Channel 272A.

¹ This application, as amended June 14, 2007, was granted this date.

² The license at Camden, Alabama can be modified to specify operation on Channel 230A in lieu of Channel 272A at the station's current authorized transmitter site (BLH-19901120KC). The authorized coordinates for the license at Camden, are 31-57-17 NL and 87-15-51 WL.

³ 47 U.S.C. § 316(a) (the "Act").

Within 30 days of the effective date of this letter, Down Home shall submit to the Commission a minor change application for construction permit (Form 301). Upon grant of the construction permit, program tests may be conducted in accordance with Section 73.1620 of the Commission's Rules. Nothing contained herein shall be construed to authorize a change in transmitter location or to avoid the necessity of filing an environmental assessment pursuant to Section 1.1307 of the Commission's Rules.
