FM BROADCAST STATION LICENSE

Subject to the provisions of the Communications Act of 1934, as amended, treaties, and Commission Rules, and further subject to conditions set forth in this license, the LICENSEE

BOOTH AMERICAN COMPANY

is hereby authorized to use and operate the radio transmitting apparatus hereinafter described for the purpose of broadcasting for the term ending 3 a.m. Local Time: OCTOBER 1, 1989

The licensee shall use and operate said apparatus only in accordance with the following terms

- 1. Frequency (MHz): 97.9MHz
- 2. Transmitter output power: 10 Kilowatts
- 3. Effective radiated power: 18 Kilowatts (H&V)
- 4. Antenna height above average terrain (feet): 380 Feet (H&V)
- 5. Hours of operation: ~~Unlimited~~ FOR AUXILIARY PURPOSES ONLY
- 6. Station location: Detroit, Michigan
- 7. Main studio location: 2050 CNB Building, Detroit, Michigan

CONTINENTAL G5CPM-4E, four sections circularly polarized, sidemounted at the 367 foot level (C/R-AGL) on a non-uniform, self-supporting steel tower, also used as AM radiator for WMZK(AM). OVERALL HEIGHT ABOVE GROUND: 432 FEET.

The licensee shall, during the term of this license, render such broadcasting service as will serve public interest, convenience, or necessity to the full extent of the privileges herein conferred.

This license shall not vest in the licensee any right to operate the station nor any right in the use of the frequency designated in the terms beyond the term hereof, nor in any other manner than authorized herein. Neither the license nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This license is subject to the right of use or control by the Government of the United States conferred by section 606 of the Communications Act of 1934.
