Dear Licensee:

We have before us the licenses for the FM Translator stations listed in the attached Appendix.

The licenses for these stations, owned by J and J Broadcasting, expired in 1990. <sup>1</sup> J and J timely filed license renewal applications for the stations in 1990. However, action on those applications has been deferred, and J and J did not file the requisite supplemental license renewal applications for the stations that were due in 1997 and 2004. <sup>2</sup> J&J's failure to file the requisite license renewal applications results in the expiration of the station licenses.

Accordingly, the 1990 renewal applications for the listed stations ARE DISMISSED, all authority to operate the listed stations IS TERMINATED, and the call letters ARE DELETED. Any operation of these facilities is now unauthorized and must cease immediately.

Finally, it is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower be maintained until the tower is dismantled. Accordingly, the owner of the tower where the referenced station's transmitting antenna must maintain the tower in the manner prescribed by the Commission's rules and the terms of the expired license.<sup>3</sup>


