Special Temporary Authorization

Dear Mr. Robbins:

This is in reference to the request filed on September 30, 2008, on behalf of Call Communications Group, Inc. ("CCG"). CCG requests further extension of the special temporary authority ("STA") granted on March 16, 2007, and modified on April 19, 2007, for operation of Station WMKL with temporary facilities. In support of its request, CCG states that it has been unable to obtain permission from the current tower owner to replace its antenna; that it filed an Application BMPED-20070521AIL for modification of construction permit to specify a new tower location, and that its application remains pending.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem. Thus, extension of STA is warranted. We note, however, that Construction Permit BMPED-

20070521AIL was granted on November 5, 2008.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WMKL may continue to operate with the following facilities:

Effective radiated power:	not to exceed 25 kilowatts (H&V)
Antenna height:	
above ground:	91 meters
above mean sea level:	94 meters

CCG must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **December 10, 2009**.
