Dear Mr. Wood:

This is in reference to the request filed March 2, 2009, on behalf of KESS-AM License Corp. ("KLC"). KLC requests extension of the special temporary authority ("STA") granted on December 3, 2008, to operate Station KFLC during nighttime hours with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits.<sup>1</sup> In support of the request, KLC states that, since the original STA filing following damage to its ground system by a pipeline company, it has worked to determine the extent of the damage and formulate a plan to return the station to licensed operation. KLC states that these efforts require careful coordination with legal counsel, engineering experts and the pipeline company.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is

warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KFLC may continue to operate during nighttime hours with parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. KLC must notify the Commission when licensed operation is restored.<sup>2</sup> KLC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **January 20, 2010**.
