Special Temporary Authority

Dear Counsel:

This is in reference to the request filed October 15, 2009, on behalf of WIBG Limited Liability Company ("WLL"). WLL requests special temporary authority ("STA") to operate Station WIBG-FM with the facilities authorized by Construction Permit BPH-20090517ACO.¹ In support of the request, WLL states that the authorized facilities are fully constructed; however, certain technical difficulties, including low transmitter efficiency, additional tower work and final survey report must be resolved before final licensing can proceed.

Our review indicates that the proposed STA operation does not comply with our rules and STA policies. Because of the potential for interference which may result from an improperly installed directional antenna, FM stations holding construction permits which authorize new directional antennas must request and receive program test authority prior to commencing operation with full power.² However, if the effective radiated power is reduced to 3 kilowatts, the proposed operation complies with the rules. STA will be granted with a power reduction to 3 kilowatts.

Accordingly, the request for STA IS HEREBY GRANTED, with modification as discussed above. Station WIBG-FM may operate with the facilities authorized by Construction Permit BPH-20090517ACO, with reduced maximum effective radiated power of 3 kilowatts:

It is anticipated that an application for license to cover Construction Permit BPH-20090517ACO will be filed prior to the expiration date below. WLL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **January 16, 2010**.

STA Advisory: Section 309(f) of the Communications Act of 1934, as amended, authorizes the Commission to grant STA in cases of "extraordinary circumstances requiring temporary authorizations in the public interest and when delay in the institution of the temporary operations would seriously prejudice the public interest." However, Section 309(f) is not a means by which a licensee/permittee may circumvent established processing procedures which require the filing of an application, nor is it a means by which a broadcaster may enhance his facility or make operation more convenient for the broadcaster. Stations operating with less than licensed facilities under temporary authorities can be viewed as receiving the benefit of a larger protection area than that in which they are currently providing service.

Accordingly, Special Temporary Authorities by nature are to be temporary and are not intended for extended use. Licensees of stations operating under temporary authorities are reminded that timely restoration of permanent facilities is the responsibility of the licensee and should be undertaken expeditiously. Any request for extension of special temporary authorities carries an increased burden with each subsequent request.

Therefore, requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.
