Special Temporary Authority

Dear Counsel:

This is in reference to the request filed December 24, 2009, on behalf of KRBE Lico, Inc. ("KLI"). KLI requests further extension of the special temporary authority ("STA") granted on April 11, 2008, to operate Station KTCK with emergency antenna facilities pursuant to Section 73.1680. In support of the request, KKLI states that it has replaced its three damaged towers; however, due to ongoing construction of two cell towers in the vicinity of the array and, due to its pending minor modification application to increase daytime power, it is not practical to conduct a proof of performance at this time.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made substantial progress toward restoring licensed operation; thus, extension of STA is warranted.

¹ KTCK is licensed for operation on 1310 kHz with 9 kilowatts daytime and 5 kilowatts nighttime, employing different directional antenna patterns daytime and nighttime (DA-2-U). Application BP-20091116ADS proposes an increase in daytime power to 25 kilowatts.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KTCK may continue to operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. KLI must notify the Commission when licensed operation is restored.² KLI must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on June 30, 2010.
