CMCG requested virtual channel 14.1 for WMEI because it matches the station's actual RF Digital Channel of 470-476 Mhz. Since WOST rebroadcasts the signal of WMEI in its entirety, the assignment of virtual channel 14.1 for WOST as well would align viewers' experiences as much as possible and would reduce viewer confusion.

With respect to the availability of virtual channel 14.1, it is our understanding that Televicentro of Puerto Rico, LLC ("Televicentro"), the licensee of stations WAPA-TV, San Juan, Puerto Rico, WNJX-TV, Mayaguez, Puerto Rico and WTIN(TV), Ponce, Puerto Rico (Fac. ID 26681) has requested virtual channel changes that will free up virtual channel 14.1. Specifically, WAPA-TV has been assigned "virtual channel" 4, while WNJX-TV and WTIN(TV) have been assigned virtual channels 22 and 14 respectively. Since WNJX-TV and WTIN(TV) retransmit WAPA-TV in its entirety, Televicentro requested that the virtual channels for WNJX-TV and WTIN(TV) be changed to channel 4 for both stations. Upon the grant of that request, virtual channel 14 will be available for use by WMEI and WOST.
