We have received the attached letters from you regarding LPTV applications BNPDTL-20090825BZG, BNPDTL-20090825BZI, BNPDTL-20090825BZJ, BNPDTL-20090825BZL, BNPDTL-20090825BZM, BNPDTL-20090825BZN, BNPDTL-20090825BZP and BNPDTL-20090825BZW needing amendments to include tower registration.

The tower indicated in the application is less than 50 feet from a taller registered tower. We were under the assumption the tower registration was not required.

Please find below the response to the case HD0000001296724

The shorter tower is still considered 'shielded' by the taller tower since it is within 50 feet of the taller tower, so it does not require registration. If he

chose to register it anyway, he would NOT be able to use the FAA for the taller tower. He would need to obtain a new FAA study. The taller tower fails TOWAIR by a lot so I'm sure the shorter tower fails too. In light of that, any license applications filed for the shorter tower would need to use the 47 C.F.R. 17.14 ASR Exemption attachment type, supplying the shielding justification.
