Gentlemen:

This is in response to your request for an experimental license for a Digital Television (DTV) booster station for DTV Station WVPT-DT, Staunton,, VA. The purpose of this license is to obtain data on the operation of on-channel DTV Booster Stations and their effectiveness (including the minimum required effective radiated power), as well as, to provide enhanced DTV service for WVPT-DT to Monterey, VA.

With respect to radio frequency radiation (RFR), we expect compliance with Section 1.1307(b) of the Commission's Rules to be achieved.

After a thorough review of the technical submissions, we are persuaded that no interference is likely to occur from the proposed operation. We therefore conclude that the public interest would be served by the grant of this license. If problems do arise, we expect them to be solved expeditiously, and the Bureau reserves the right to require the termination of the operation without further notice.

Accordingly, your request for an experimental license for DTV Station WVPT-DT, Staunton, VA to operate a DTV Booster station to serve Charlottesville, VA is GRANTED subject to the terms and conditions specified below. This authorization expires on April 6, 2006. Temporary call sign WVPT2-DT has been assigned.
