Dear Licensee:

Arnold Broadcasting, Inc. ("Arnold"), licensee of FM broadcast station KECK(FM), Eckley, Colorado, is hereby notified of the modification of the KECK(FM) license, File No. BLH-20080229AAG, to specify operation on Channel 257C1.

On February 13, 2009, Kona Coast Radio, LLC ("Kona"), permittee (File No. BNPH-20070502AFR) of Station KMAP(FM), Arriba, Colorado, filed an application for minor modification of construction permit (File No. BMPH-20090213GWP) which requested substitution of Channel 257C1 for Channel 237C1 at Eckley, Colorado, and modification of the above captioned KECK(FM) license.¹ Section 316(a) of the Communications Act of 1934, as amended,² permits us to modify a license or a construction permit if such action is in the public interest. The Act requires that we notify the affected licensee of the proposed action and the public interest reasons for the action, and afford the licensee at least 30 days to respond. Accordingly, by staff letter dated June 15, 2009, Arnold was directed to show cause why its license should not be modified to specify operation on Channel 257C1 in lieu of Channel 237C1. As of this date, no response from Arnold has been received.

¹ The KECK(FM) license can be modified to specify operation on Channel 257C1 in lieu of Channel 237C1 at Eckley, Colorado, at the station's currently licensed transmitter site. The geographic coordinates of the licensed KECK(FM) transmitter site are 40° 00' 33" North Latitude, 102° 45' 35" West Longitude (1927 North American Datum).

Accordingly, pursuant to the authority found in 47 U.S.C. Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) and 47 C.F.R. Sections 0.61, 0.204(b) and 0.283, IT IS ORDERED, that effective on the date of this letter, the FM assignment IS MODIFIED as follows:

Add 257C1, Delete 237C1

Pursuant to Section 316(a) of the Communications Act of 1934, as amended, KECK(FM) license BLH-20080229AAG IS MODIFIED to specify operation on Channel 257C1 in lieu of Channel 237C1.

Within 30 days of the date of this letter, Arnold shall submit to the Commission a minor change application for construction permit (Form 301). Upon grant of the construction permit, program tests may be conducted in accordance with Section 73.1620 of the Commission's Rules. Nothing contained herein shall be construed to authorize a change in transmitter location or to avoid the necessity of filing an environmental assessment pursuant to Section 1.1307 of the Commission's Rules.
