Dear Applicant:

This letter refers to the above-captioned minor change non-commercial educational construction permit application filed to modify the broadcast facilities of WQRA(FM).

By letter dated May 12, 2009 the Commission stated that the proposed construction permit application had to obtain FCC antenna structure registration. The letter stated that pursuant to Section 17.4(a) of the Commission's Rules,<sup>1</sup> any proposed construction of a new antenna structure or proposed alteration of an existing antenna structure that requires notification to the Federal Aviation Administration (FAA) requires registration with the Commission prior to construction or alteration. In addition, the letter required the submission of written updates every 60 days. By letter dated October 13, 2009 the applicant requested an extension of time to amend WQRA(FM)'s application to obtain tower registration. On January 21, 2010, EMF's counsel sent an e-mail requesting an additional extension of time to the end of March to file information regarding the tower registration. However, since that time there has been no status updates nor an amendment filed supplying the required registration number. Further inquiry of the FAA notification system indicates that the proposed structure has not yet received a determination of no hazard to air navigation. Thus, the tower has not been registered.

To date, almost three years have passed since the application claimed that notification has been filed with the FAA. In addition, based on updates from the contact representative, the applicant has failed to receive an FAA determination of no hazard. Furthermore, WQRA(FM) has not provided an update on their efforts to resolve the situation in over three months.
