Dear Counsel:

This is in reference to the request filed February 26, 2010, on behalf of Quantum of Florence License Company, LLC (“QFL”). QFL requests extension of the special temporary authority (“STA”) granted on December 3, 2009, to operate Station WEGX with reduced power.¹ In support of the request, QFL states that it has not yet been able to repair problems with its transmission line due to weather and scheduling delays. QFL estimates that repairs should be completed within 90 days.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WEGX may

continue to operate with reduced power. QFL must notify the Commission when licensed operation is restored. QFL must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **August 5, 2010**.
