Dear Licensee:

Carolina Radio Group, Inc. ("CRGI") is hereby notified of the modification of its license for WZTK(FM), Burlington, NC, to specify operation on Channel 266C0.

On September 2, 2009, NM Licensing LLC Debtor in Possession ("NM Licensing"), licensee of station WQZL, Belhaven, NC, filed a minor change application. NM Licesing's application proposed that WZTK's license and assignment be modified to specify Class C0 in lieu of Class C in accordance with the procedures set forth in Note 4 of 47 C.F.R. § 73.3573.² Accordingly, by staff letter dated March 31, 2010, WZTK was given thirty days notice to show cause why its license should not be modified to specify Channel 266C0 in lieu of Channel 266C. The letter stated that failure to respond to this letter will result in the automatic downgrade of WZTK. As of the date of this letter, CRGI has failed to file a response to the March 31, 2010 letter.
