Dear Counsel:

This is in reference to the request filed June 10, 2010, on behalf of Multicultural Radio Broadcasting Licensee, LLC ("MRB"). MRB requests further extension and modification of the special temporary authority ("STA") granted on January 11, 2007, to operate Station WLXE with emergency antenna facilities pursuant to Section 73.1680.<sup>1</sup> In support of the request, MRB states that the station's nighttime directional antenna system was severely damaged by construction equipment and that repairs were nearly complete when a vehicle struck one of the station's guy anchors and caused the center tower to collapse. MRB states that, although it had been hopeful that it could obtain a new leasing agreement for restoration of licensed operation, it is now clear that this will not occur. MRB requests further extension of STA while it searches for a new site.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem.

<sup>1</sup> WLXE is licensed for operation on 1600 kHz with 1 kilowatt daytime and 0.5 kilowatt nighttime, employing a directional antenna during nighttime hours only (DA-N-U).

Thus, extension of STA is warranted.

Accordingly, the request for modification and extension of STA IS HEREBY GRANTED. Station WLXE may continue to operate during daytime hours with an alternate tower and during nighttime hours with an emergency nondirectional antenna and reduced power not to exceed 0.125 kilowatt. It will be necessary to further reduce power or cease operation if complaints of interference are received. MRB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **January 1, 2011**.
