Request For Special Temporary
Authority To Remain Silent

Dear Mr. Macintosh:

This letter concerns the requests, filed on May 24, 2010, on behalf of Horizon Christian Fellowship ("Horizon"), for Special Temporary Authority to permit FM Translator Stations K217FB, K213EP, K204FM, W276BI and K218DZ to remain silent.

Horizon's requests state that K217FB, K213EP, K204FM, W276BI and K218DZ went silent on May 6, 2010, for financial reasons. Horizon's requests include the appropriate certification regarding Section 5301 of the Anti-Drug Abuse Act of 1988.¹

Horizon's requests will be granted. Accordingly, Special Temporary Authority is granted to permit Stations K217FB, K213EP, K204FM, W276BI and K218DZ to remain silent not to exceed 180 days from the date of this letter. **Notwithstanding the grant of this special temporary authority, the broadcast licenses for K217FB, K213EP, K204FM, W276BI and K218DZ will automatically expire as a matter of law if broadcast operations do not commence by 12:01 a.m., May 7, 2011.**² See Section 312(g) of the Communications Act, 47 U.S.C. Section 312(g).

The stations' silent status does not suspend the licensee's obligation to comply with all other relevant Commission rules, including the filing, when appropriate, of applications for renewal of broadcast license. Finally, we note that it is imperative to the safety of air navigation that any prescribed painting and illumination of the station's tower shall be maintained until removed. See 47 C.F.R. Sections 17.6 and 73.1740(a)(4).
