Dear Ms. Dortch:

On behalf of Living Bread Radio, Inc., Licensee of Station WILB (AM), Canton, OH, there is transmitted herewith a response to the above-referenced Blanketing Interference Complaint submitted by a Mr. Virgil Wright, President of the Terrace Club Condo Association Board (the "Response").

The Response details the actions taken by the Licensee to resolve the interference problems encountered by the residents in the Condo unit, and the problems encountered by Mr. Wright.

This Response was initially mailed to the FCC directly by the Licensee on February 5, 2010, by certified mail with delivery confirmation, but apparently was not received by the Commission because of adverse winter weather conditions until February 16 or 17th. A copy of the certified letter receipt from the Post Office, and a copy of the online tracking confirmation of delivery to the FCC are attached as page 9 of the Response. However, no date-stamp copy was included for return by the FCC to the Licensee, and Staff in the Audio Division report that the Response letter from the Licensee was never received there. The February 4, 2010 Response letter from Living Bread Radio, Inc. is being resubmitted in order to provide an official transmission of the Response..

In addition, a letter from Mr. Virgil Wright confirms that WILB has adequately responded to resolve the interference complaints in the condominium building. Living Bread Radio will submit in the near future a further update to the response efforts detailed in its February 4 letter to the Commission.



Dear Sir or Madam:

This is in response to the Commission's letter to LBR concerning complaint #09-C00171303-1, dated January 8, 2010. The complainant is Mr. Virgil Wright, President of the Terrace Club Condominium Association, whose building adjoins the WILB transmitter site. This building was erected in 2005 and occupied in 2006. The building is located within the WILB 1000 mV/m blanketing contour. Prior to receiving the Commission's blanketing interference letter, WILB had received no complaints from anyone in the condo building. We had, however, been contacted by the condo building's alarm system provider (See below).

Background

The WILB transmitter site, which encompasses 7 acres, was established in 1947 as WCMW on 1060 kHz at 1.0 kilowatt Non-Directional. The site has been in continuous use as the 1060 AM site in NW Canton, Ohio since that time. In 1947, the site was surrounded by farmland. Today, the site is surrounded by businesses and residential developments.

In 1963 the station increased power to 5 KW DA-D. In 2009 under the present ownership, the station increased power to 15 KW DA-D with a modified directional pattern. WILB is currently operating under Program Test Authority. The subject condo building was built in 2005 and is actually adjoining the WILB site in the main lobe of the radiation pattern (See map, attachment A).

Blanketing Interference

Mr. Wright complains of radio frequency interference (RFI) affecting the building alarm system and, on behalf of the residents/condo owners, of TV interference and telephone interference. Mr. Wright is also a resident of the condo building, but reports no interference to his personal equipment. LBR contends that it is important to realize that interference had been received in the newly built condo building prior to WILB increasing power per Program Test Authority. Therefore, it cannot be stated that all the interference now being received is a direct result of the power increase.

Living Bread Radio Response

On January 19, Ms. Barbara Gaskell, President of LBR and WILB contract engineer William Glasser, CPBE met with Mr. Wright to assure him of our cooperation in resolving his complaints. We explained that we would need to identify the actual residents experiencing interference. We gave him a quantity of our business cards, asked him to distribute them to all residents in the building, asking them to contact WILB directly if they had interference to report. To date, we have been contacted by 11 residents in the building. Their complaints vary as follows:

- 6 Cases...WILB audio in telephone(s).
- 5 Cases...WILB heard over other (desired) AM broadcast stations (BCI).
- 2 Cases...WILB audio in TV (cable).
- 2 Cases...WILB audio in computer speakers.

WILB is in the process of evaluating each case. We are purchasing necessary materials and filters to address CATVI, phone interference and speaker interference, as needed. In the case of AM broadcast interference (BCI), the probable cure is to purchase a better quality AM-FM radio for each case. We are addressing interference to telephones and audio devices even though they are not covered under the blanketing rules. To date we have resolved 7 of these complaints and are continuing to address the others (See detailed list, Attachment B).

Concerning the building alarm system, which is not covered since it is a non-RF device, we have been working with the contractor and offering technical advice. Mr. Glasser met with the contractor in mid November. We will continue to cooperate with him in resolving this RFI issue.

WILB is working with the complainant, Mr. Virgil Wright on a day to day basis as we work through the list. Mr. Wright has been very cooperative in working with us. Living Bread Radio will follow up with a further report when all complaints have been satisfied, or whenever the Commission requires.

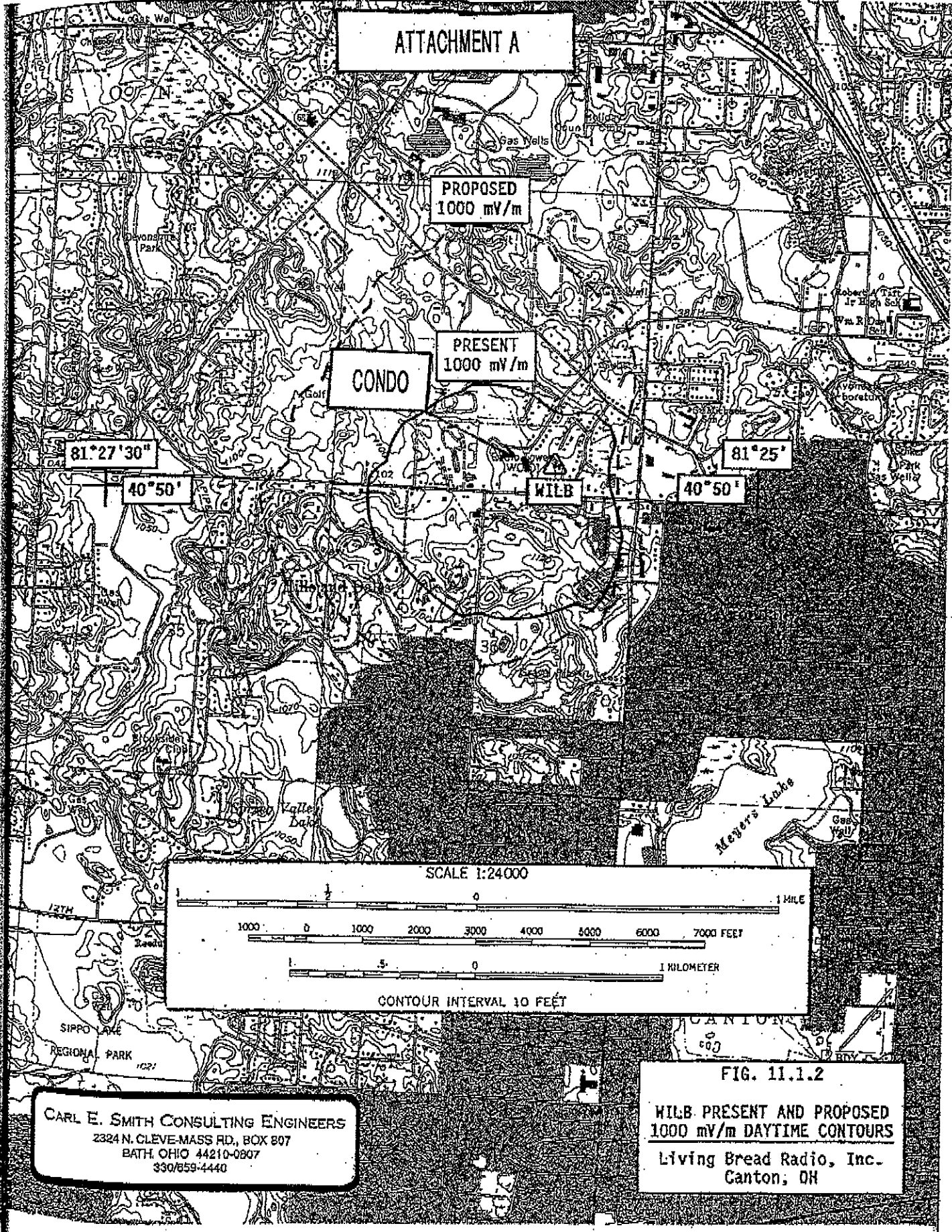

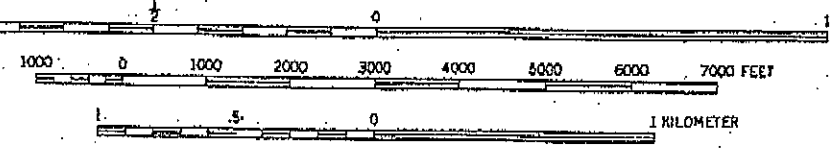

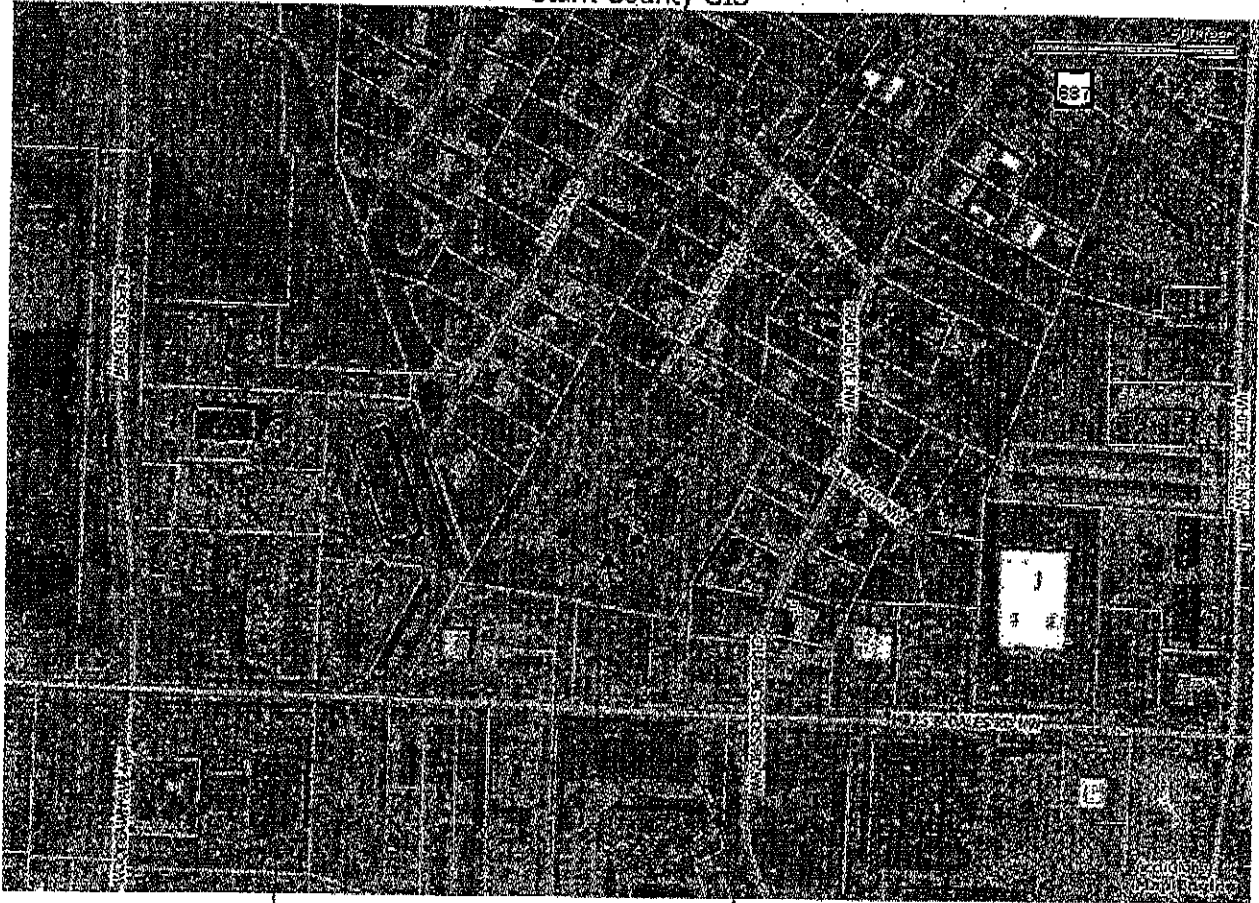
