On July 29, 2010, Oklahoma Community Television, LLC (OCT), through counsel, submitted the attached paper filing requesting authority for various analog TV translator stations to remain silent pursuant to Special Temporary Authority (STA). All of the analog stations associated with the July 29 filing have associated digital facilities that have been (or will soon be) constructed but are not yet licensed.

The STA request was filed on paper due to the number of stations involved and the financial burden associated with requesting individual STAs electronically for each station using CDBS. OCT has a small budget and therefore requests a waiver of any requirement to file the STA requests using CDBS.

Accordingly, OCT requests that the Commission process the July 29 request, subject to the following amendments and additions:
