Oklahoma Community Television, LLC (OCT), by its counsel, hereby respectfully requests Special Temporary Authority (STA) for the following analog television translator stations, all of which are licensed to OCT, to remain silent for up to six months:

The above facilities temporarily ceased operations on or about July 19, 2010. OCT is requesting STA for these stations to remain silent because they are associated with digital facilities that have recently commenced operations. Due to the financial impracticality of operating the analog stations in tandem with the digital facilities, OCT requests authority for these stations to remain silent for up to 6 months.

No filing fee is required for this filing according to Footnote 3 of the Commission's Application Fee Filing Guide for Media Bureau publication.
