On behalf of WAMC, we hereby notify the Commission of the commencement of digital broadcasting, using iBiquity Digital Corporation's HD Radio™ technology, over the facilities of noncommercial educational radio station WWES(FM), Channel 205, Mount Kisco, New York. Consistent with the Commission's order on interim digital operations in *Digital Audio Broadcasting Systems and Their Impact on the Terrestrial Radio Broadcast Service*, MM Docket No. 99-325, *First Report and Order* (October 11, 2002), WAMC supplies the attached information in support of this notification.

WAMC is a noncommercial educational licensee and operates Station WWES(FM) on a noncommercial educational basis. This station is therefore exempt from FCC filing fee requirements pursuant to Section 1.1116 of the Commission's Rules, and the facility is exempt from FCC regulatory fees, pursuant to Section 1.1162 of the Rules.



Notification of Digital Radio Operation

NCE Station WWES(FM), Channel 205, Mount Kisco, NY (Facility ID No. 176621)

1. *Power Level & Date.* WWES(FM) commenced digital radio operation with a power of 1% of analog ERP on October 20, 2010.
2. *Certification of Facilities.* WAMC, licensee of WWES(FM), hereby certifies its facilities conform to the iBiquity Digital Corporation hybrid FM specifications.

6. *Digital Power Level.* The station operates with the following ERP:
Analog: 200 watts
Digital: 2 watts
7. *Radiation Exposures Certification.* WAMC hereby certifies that its interim digital operations will not cause human exposure to levels of radio frequency radiation in excess of Section 1.1310 of the Commission's rules and is therefore categorically excluded from environmental processing pursuant to Section 1.1306(b).
