Dear Mr. Magarelli:

This is in reference to the request filed September 23, 2010, on behalf of Scottsdale Italian Social Club ("SISC"). SISC requests special temporary authority ("STA") for operation of Station KWSS-LP on a non-adjacent channel and from a site other than the licensed site.<sup>1</sup> In support of the request, SISC states that pending applications by cochannel Station KNKI, Pinetop, Arizona; and first-adjacent channel Station KDVA, Buckeye, Arizona, will displace Station KWSS-LP from its currently licensed operation.<sup>2</sup> For reasons which are discussed below, the request is denied.

Our review indicates that SISC is proposing a change in operating channel, which is more properly considered in the context of an application for construction permit than in a request for STA. Moreover, SISC has not presented any information which would indicate that its currently licensed operation is in immediate jeopardy from the proposed, modified facilities of Stations KNKI and KDVA. Our records indicate that Station KWSS-LP continues to operate as licensed.

Accordingly, the request for STA IS HEREBY DENIED. This action is taken pursuant to 47 CFR Section 0.283.

<sup>1</sup> KWSS-LP is licensed for operation on Channel 294L1 (106.7 MHz) with effective radiated power ("ERP") of 0.1 kilowatt and antenna height above average terrain ("HAAT") of 17 meters.

<sup>2</sup> Comments were filed on September 28, 2010, by Entravision Holdings, LLC, licensee of Station KDVA, disputing certain statements made by SISC in its STA request. In light of the action taken herein, it is not necessary to consider Entravision's comments.
