Dear Mr. Monahan:

This refers to the above-captioned minor change application for radio KIKO(AM) to change the city of license from Miami, Arizona to Superior, Arizona, and reduce the power.

A preliminary study of the application reveals the following deficiencies:

- 1. The proposed daytime antenna efficiency is incorrectly calculated. Based on the proposed ground system, the correct efficiency must be 247.00 mV/m/kW at 1 kilometer.
- 2. The graphs of the conductivities measurement data used in the allocation studies are not provided. Without considering the measurement data, we find that the proposal would cause prohibited contour overlap to first-adjacent station KJLL(AM), South Tucson, Arizona, in violation of Section 73.150 of the Commission's rules.
- 3. Complete daytime and nighttime allocation studies are not included.
- 4. A sketch of the proposed antenna system and the ground system, and the 1V/m blanketing contour Exhibit are not supplied.
- 5. The proposed tower is close to an airport and must be registered. Pursuant to 47 C.F.R. § 17.4(a)(1), as modified by the *Report and Order* in WT Docket 95-5, 61 FR 4359 (1996), any proposed antenna structure or existing antenna structure must be registered with the Commission. Our records indicate that the proposed antenna structure has not been registered. Thus, we are unable to continue processing the application. Accordingly, the antenna structure must be registered by filing an FCC Form 854, Application for Antenna Structure Registration, with the Commission's Support Services Branch (SSB) of the Wireless Telecommunications Bureau's Customer Services Division in Gettysburg, Pennsylvania. Upon registration, written notification (including the registration number) must be submitted to the Audio

Division (AD). If the antenna structure cannot be successfully registered within sixty days of the date of this letter, KIKO(AM) must notify the Audio Division in writing.

Further action on the subject application will be withheld for thirty (30) days from the date of this letter in order to provide an opportunity to file a curative electronic amendment. Failure to respond or file an amendment within this time period will result in the dismissal of the application pursuant to Section 73.3568 of the Rules.
