Dear Mr. Jenkins:

By letters dated March 23, 2011, the Video Division requested information from Ponchatrain Investors, LLC, the licensee of Class A television station WSTY-LP, Hammond, Louisiana, and Great Oaks Broadcasting Corporation, the licensee of Class A television station KMNO-LP, Monroe, Louisiana, regarding their apparent failure to make the required quarterly Form 398 electronic filings for the stations for the past four and five years, respectively. The letters also stated that if the failure to make the quarterly filings was due to the licensees' election to let the stations revert to low power television status, they need only notify the Commission of this election and request a change in status for the station as permitted by Section 73.6001(d) of the Commission's rules.

In an email dated April 25, 2011, you stated that rather than be subjected to fines for the licensees' failure to comply with the Commission's children's television programming rules, you agree to give up Class A television status for WSTY-LP and KMNO-LP. Please be informed that we have changed the status of WSTY-LP and KMNO-LP to low power television status as requested and that no further action is required of Ponchatrain Investors, LLC and Great Oaks Broadcasting Corporation.

Today I received in the mail two disturbing letters from Barbara Kreisman of the Video Division: One letter was to Ponchartrain Investors, LLC, regarding WSTY-LP in Hammond, LA, and the other was to Great Oaks Broadcasting Corp. regarding KMNO-LP in Monroe, LA.

Both letters were dated March 23, 2011, but were only received today, April 25, 2011!

The letters said we have failed to file Children's Program reports and that we will be subject to large fines unless we agree to give up our Class A status within 30 days of the March 23 letters.

We feel we should have been given some notice or opportunity to correct any filing deficiencies.

However, if this is our only option, then we agree to give up our Class A status on both stations.
