PETITION FOR RECONSIDERATION

Juan Alberto Ayala, by its attorney, hereby requests reconsideration of the Letter of the Media Bureau dated June 8, 2011, cancelling the station license of FM translator station K262BP.¹ With respect thereto, the following is stated:

As the Commission's Letter states, Station K262BP went off the air on February 24, 2010 due to loss of its transmitter site. As the Commission's CDBS reflects, an application for a new site was filed shortly thereafter, on March 10, 2010, which was then dismissed on June 9, 2010, due to prohibited overlap with a full-service FM station. A new site was procured, and filed for on July 29, 2011. After the application was perfected by amendment filed on November 8, 2010, that application was granted on November 22, 2010.

As confirmed by numerous letters attached hereto, K262BP thereafter restored operations almost immediately at the new site – on December 1, 2010. It has remained on the air at that authorized site since that time. Through inadvertence, at the time it did not file a license to

cover its construction permit or notification to the FCC that service had been restored. Both of those deficiencies now have been rectified. Letters from the licensee; the Pastor at Manatíal De Vida Eterna Church (whose programming is rebroadcast on the station); from the licensee of KAFY(AM) (the station currently being rebroadcast); and from other listeners of the station, all of which confirm that the station has been on the air and operational since December 2010 are attached. Attachment 1. Also attached are photographs of the station's transmitter, tower, and antenna. Attachment 2. Finally, it should be noted that Station K262BP was inspected by the FCC Field Office on April 15, 2011. The FCC Enforcement Bureau, Los Angeles Office, Western Region, also will be able to confirm that the Station was on the air prior to the issuance of the FCC's June 8, 2011 Letter.

Therefore, at no time has Station K262BP been off the air for a greater-than 12 month period in violation of 47 U.S.C. § 312(g) or 47 C.F.R. § 73.1740(c). It therefore is requested that the license be reinstated.

Accordingly, it is requested that this Petition for Reconsideration be granted, and that the Commission reinstate the license of Juan Alberto Ayala for Station K262BP be reinstated.

DECLARATION

I, Juan Alberto Ayala, hereby state under penalty of perjury as follows:

1. I am a Pastor of Templo Apostoles Y Profetas Bethel. I also am the original permittee of Station K262BP. The original permit was granted on March 3, 2005, and was licensed on March 13, 2008.


2. When the original transmitter site for the station became prohibitively expensive, the original transmitter site for the Station was lost on February 24, 2010. An application was filed on my behalf for permission to go silent on March 10, 2010, which was granted on April 13, 2010.

3. With the assistance of my consultant and friend, Antonio Cesar Guel, I then began the search to find a new site to get back on the air as soon as possible. One site was filed for at the same time I requested silent authority, on March 10, 2010. That site initially did not work out, and the application was dismissed June 9, 2010. Once it was determined that the defects in the application could be fixed, a new application was filed. The site is a registered tower. The new application for that site was filed on July 29, 2010. The application was ultimately granted on November 22, 2010. While the application was being processed, I learned from my consultant, Mr. Guel, that Elene Hernandez (who is the Pastor of Manatial De Vida Eterna, a sister church located in Bakersfield, California, that is leasing time on Station KAFY(AM) in Bakersfield, California) was looking for an FM translator that could be used to rebroadcast KAFY(AM). I agreed to allow rebroadcast of Station KAFY(AM) to occur on K262BP, and on my behalf she helped with the new transmitter site (the station's current site) on my behalf.

4. A lease for the site already was signed when the modification application was granted. The equipment already was on hand. Therefore, I was able to get the station back on the air almost immediately thereafter, on December 1, 2010. Members of the tower crew that placed the station back on the air are providing letters confirming the date the station went back on the air.

5. The station has been on the air continuously since that time. I am now aware of the fact that an application for license to cover the November 22, 2010 permit (along with notification to the FCC that the station was back on the air) should have been immediately filed after the station went back on the air on December 1, 2010. I inadvertently did not file those materials until just recently. I respectfully request the FCC's forgiveness and indulgence for this oversight.

I declare under penalty that the forgoing is true is correct.



To whom it may concern,

My name is Ricardo Hernandez. I install antennas. In the middle of November 2010 we were contacted by Antonio Cesar Guel and preacher Juan Ayala in the City of Dallas Texas to make an instillation to a transmitter for a radio FM in the City of Conner CA, this is like 5 miles from Bakersfield CA. Around the last days of November my crew left around 5:00 AM to go from Dallas, Texas to the City of Bakersfield, California. The trip went as planned. We drove 14 to 15 hours and we stopped to sleep in Flagstaff AZ, and the next day we got back on the road and we drove around 12 hours more and we got to Bakersfield CA. Once we got there we immediately headed to the place of installations to see the structure of the tower.

After we checked the tower we went to eat and then we went to sleep in a Hotel so we can wake up the next morning really early and start making the instillation. The next day we installed the antennas on the tower and then the 7/8 inch coaxial cable. After that, we installed a Crown 300 watt transmitter. This installation all together lasted 8 hours straight. In the afternoon we started to transmit the signal live. We went around the city to see what would cover the signal and on that same day the transmitter was adjusted. In my opinion, the installation came out great. The people from church invited us to have dinner and we finished at 12:00 AM and we left to go sleep in a hotel and the next day we started making our way to the City of Dallas TX.






To Whom This May Concern:

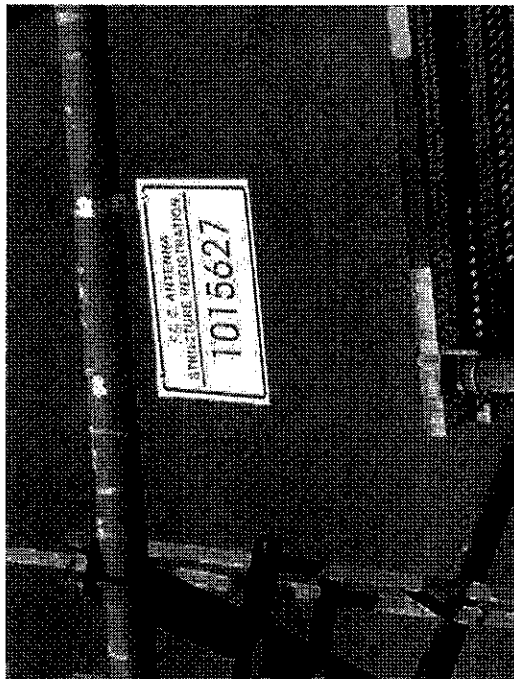
My congregation and I, Pastor Roberto Cedillos, strongly support this radio station. Many people's lives are being restored and guided towards living a successful life.

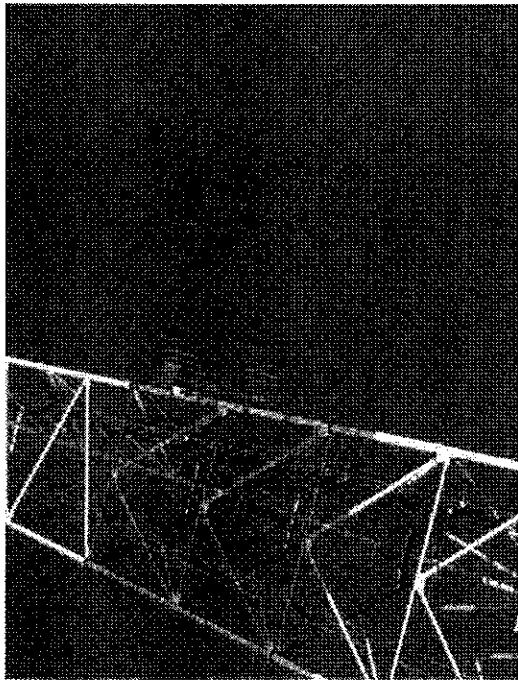

CONSTRUCTION PERMIT



ALL APPLICANTS FOR A CONSTRUCTION PERMIT SHALL COMPLY WITH THE FOLLOWING REQUIREMENTS:

1. The applicant shall file with the Commission a copy of the proposed construction plan, showing the location, extent, and nature of the proposed construction.

2. The applicant shall file with the Commission a copy of the proposed construction schedule, showing the estimated date of completion of the construction.

3. The applicant shall file with the Commission a copy of the proposed construction budget, showing the estimated cost of the construction.

4. The applicant shall file with the Commission a copy of the proposed construction contract, showing the terms and conditions of the construction.

5. The applicant shall file with the Commission a copy of the proposed construction agreement, showing the agreement between the applicant and the relevant authorities.

6. The applicant shall file with the Commission a copy of the proposed construction permit, showing the details of the proposed construction.

7. The applicant shall file with the Commission a copy of the proposed construction report, showing the results of the construction.

8. The applicant shall file with the Commission a copy of the proposed construction certificate, showing the completion of the construction.

9. The applicant shall file with the Commission a copy of the proposed construction certificate of completion, showing the completion of the construction.

10. The applicant shall file with the Commission a copy of the proposed construction certificate of acceptance, showing the acceptance of the construction.
