Translator Stations held by Freedom Broadcasting of Oregon Licensee, LLC


Dear Ms. Dortch:

This letter is submitted on behalf of the Freedom Communications Broadcast Trust,  
which controls Freedom Broadcasting of Oregon Licensee, LLC ("Freedom").
