## SUBMISSION OF CONSENT STATEMENT

Cochise Broadcasting LLC ("Cochise"), licensee of Station KWWY(FM), Shoshoni, Wyoming, hereby submits the attached "Consent Statement" signed by Ted Tucker, Managing Member of Cochise.

As the Commission is aware, Cochise had objected to two requests submitted by Global News Consultants, LLC ("Global") for program test authority (the "PTA Requests") for Station KYTS(FM), Manderson, Wyoming. Global, as the permittee of Station KYTS, holds a modified construction permit (File No. BMPH-20100729AAR), which conditions the KYTS modification on a KWWY channel change. In its PTA Requests, Global had asked the Commission essentially to ignore the KWWY special operating condition even though Cochise had not yet effectuated the KWWY change. In response to these PTA Requests, Cochise had

objected because of Global's attempt to ignore the KWWY special operating condition and because of Global's failure to fully meet its reimbursement obligations to Cochise for making the KWWY change.

Global has now made satisfactory arrangements for its reimbursement obligations to Cochise. Consequently, Cochise hereby withdraws its objections to the issuance of program test authority for the KYTS modification. Further, Cochise's plans for construction of the new KWWY channel are now in progress.

WHEREFORE, for the reasons set forth herein. Cochise submits its attached "Consent Statement" and thereby withdraws its objections to Global's PTA Requests.

## CONSENT STATEMENT

I, Ted Tucker, am Managing Member of Cochise Broadcasting LLC ("Cochise"), licensee of Station KWWY, Shoshoni, Wyoming. In response to the Request for Program Test Authority filed by Global News Consultants, LLC ("Global"), permittee of Station KYTS, Manderson, Wyoming, Cochise objected to the Request because Global's KYTS permit had a Special Operating Condition requiring KYTS to wait until KWWY changed channels and commenced program tests. The KWWY permit does not expire until January 24, 2014. In addition, Global is required to reimburse Cochise for its expenses in changing channels.

Global has now made satisfactory arrangements to reimburse Cochise for its expenses. In addition, plans for construction of the channel change are underway and completion is scheduled by the end of October. As a result, Cochise no longer objects to the issuance of Program Test Authority to Station KYTS so that it can commence operations as soon as possible. When KWWY recommences operations, it will do so on Channel 293 in accordance with its construction permit rather than on Channel 292.

Accordingly, Cochise consents to the issuance of Program Test Authority for Station KYTS and dismissal of its Response to Request for Program Test Authority.
