Dear Ms. Dortch:

Pursuant to Section 73.1125(d)(1) of the Commission's Rules, Davidson Media Station KLBB Licensee, LLC, and Davidson Media Station KLBP Licensee, LLC, respective licensees of the above-referenced stations, hereby notify the Commission that the main studio for KMNV and KMNQ has been relocated to 2920 144th Ave. NE, Ham Lake, MN 55304. This location satisfies the requirements of Section 73.1125 as follows:

- **KMNV:** The new main studio is located within twenty-five miles of the reference coordinates of the center of St. Paul, MN, KMNV's community of license. 47 C.F.R. § 73.1125(a)(3).
- **KMNQ:** The new main studio is located within twenty-five miles of the reference coordinates of the center of Brooklyn Park, KMNQ's community of license. 47 C.F.R. § 73.1125(a)(3).
