
DISMISSAL OF INFORMAL OBJECTION


DECLARATION OF CHARLES T. LANKTREE

My name is Charles T. Lanktree. I am the Managing Member of Solution Funding, LLC ("Solution"), which on March 19, 2012, filed an informal objection (the "Objection") to the assignment application for WXBR, Brockton, Massachusetts, File No. BAL-20120213ACA, from BTR Boston, Inc. ("BTR") to Azure Media, LLC.

Solution dismissed its Objection on May 15, 2012. Solution has not been promised or paid any monetary consideration in connection with such dismissal. The Objection, which was predicated on a creditor-rights dispute between Solution and BTR, became moot as a result of an agreement between BTR and Solution regarding preservation of the related sales proceeds pending judicial determination of certain of BTR's creditors' (including Solution's) priority entitlements to such proceeds.

I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge and belief.


