Dear Counsel:

This is in reference to the request filed April 12, 2012, on behalf of Multicultural Radio Broadcasting Licensee, LLC ("MRB"). MRB requests further extension of the special temporary authority ("STA") granted on January 14, 2011, to operate Station KXYZ with emergency antenna facilities pursuant to Section 73.1680.¹ In support of the request, MRB states that its efforts to restore licensed operation have been delayed by the serious illness of its engineer.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KXYZ may continue to operate during nighttime hours with an emergency nondirectional antenna and

reduced power not to exceed 1.25 kilowatts. It will be necessary to further reduce power or cease operation if complaints of interference are received. MRB must notify the Commission when licensed operation is restored.² MRB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **November 22, 2012**.
