**Re: REQUEST TO DISMISS
Modification of License Application
WLVM(FM), Mobile, Alabama (FIN:70657)
FCC File No. BMLED-20120313ABW**

Dear Ms. Dortch:

On behalf of Educational Media Foundation ("EMF"), approved assignee of WLVM(FM), Mobile, Alabama, this letter is to request the dismissal of the above-referenced application for a modification of license application to convert WLVM to noncommercial status and concomitant main studio waiver request.

On February 17, 2012 an application was filed seeking Commission consent to the voluntary assignment of license of WLVM(FM), Mobile, Alabama from WABB-FM, Inc. to EMF. See FCC File No. BALH-20120217AAT. Soon thereafter, on March 13, 2012, EMF filed the above-referenced modification of license application to convert WLVM to noncommercial status and also requested a main studio waiver. The assignment application was granted on May 2, 2012 and the Form 732 authorization included a grant of the above-captioned application along with main studio waiver, both contingent upon consummation. EMF hereby requests a dismissal of the above-captioned application and main studio waiver, and requests reissuance of the Form 732 authorization to exclude the grant language related to the above-captioned application.


Upon consummation, EMF plans to operate WLVM as a commercial station with a main studio that complies the Commission's rules. Therefore, EMF also hereby amends the Assignee's portion of the WLVM assignment application (FCC File No. BALH-20120217AAT) to revise the necessary certifications, see Exhibit A.

Accordingly, EMF requests that the Commission dismiss the above-referenced WLVM license application and reissue the Form 732 authorization related to the WLVM assignment application removing all references to the above-captioned application.

EXHIBIT A

EMF hereby amends FCC File No. BALH-20120217AAT, Section III as follows:

Item 6(b), Exhibit 17 should read as follows:

EDUCATIONAL MEDIA FOUNDATION ('EMF') IS THE LICENSEE OR PERMITTEE OF NONCOMMERCIAL EDUCATIONAL STATIONS THROUGHOUT THE UNITED STATES. SEE ATTACHED NONCOMMERCIAL EDUCATIONAL CERTIFICATION AND SECTION II OF FCC FORM 340.

PURSUANT TO SECTION 73.3555(a)(1)(iv), EVEN IN THE MOST RESTRICTED MARKET, AN APPLICANT MAY OWN 5 COMMERCIAL RADIO STATIONS IN TOTAL AND NOT MORE THAN 3 IN THE SAME SERVICE. UPON CONSUMMATION, WLVM WILL BE THE ONLY COMMERCIAL RADIO STATION LICENSED TO EMF. THEREFORE, EMF COMPLIES WITH THE COMMISSION'S MULTIPLE OWNERSHIP RULES.
