Dear Counsel:

This is in reference to the request filed August 7, 2012, on behalf of Radio Vision Cristiana Management ("RVCM"). RVCM requests further extension of the special temporary authority ("STA") granted on November 2, 2009, to former licensee Esfuerzo de Union Cristiana, to operate Station WVZN with temporary facilities. In support of the request, RVCM states that it continues its diligent search for a new site.

We note that the previous STA expired on April 13, 2012. Our review indicates that the circumstances presented warrant grant of STA in order to provide for service to the public, and that the requested STA facilities are the same as were previously authorized. However, in light of the lapse of time between the expiration of the prior STA and the filing of the instant request, it will be considered as a request for a new STA; the authority granted will not cover the period between the expiration of the prior STA and the filing of the instant request.

Accordingly, the request for STA IS HEREBY GRANTED. Station WVZN may operate with the following facilities:

Geographic coordinates 40° 01′ 28″ N, 76° 28′ 31″ W (NAD 1927)

Frequency 1580 KHz Hours of operation Unlimited

Operating power Not to exceed 0.5 kW daytime, 0.005 kW nighttime

Antenna type long wire
Overall height 9.1 meters (30')

It will be necessary to further reduce power or cease operation if complaints of interference are received. RVCM must use whatever means are necessary to protect workers and the public from

¹ WVZN is licensed for operation on 1580 kHz with 0.5 kilowatt daytime and 0.005 kilowatt nighttime, employing a nondirectional antenna (ND-2-U).

exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. The authority granted herein does not cover the period between April 13, 2012, and August 7, 2012, and is without prejudice as to whatever action the Commission may take with respect to operation of Station WVZN during the foregoing period.

This authority expires on February 20, 2013.
