Dear Counsel:

This is in reference to the request filed August 28, 2012, on behalf of Multicultural Radio Broadcasting Licensee, LLC ("MRB"). MRB requests modification and further extension of the special temporary authority ("STA") granted on October 18, 2010, to operate Station KSJX with emergency antenna facilities pursuant to Section 73.1680. In support of the request, MRB provides a report of its progress toward restoration of its transmitting facilities which were destroyed by a brush fire. MRB states that both the daytime and nighttime patterns are operating in substantial adjustment at full power, and that it expects to submit Form 302-AM within the next two to three months.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee made substantial progress toward restoration of licensed operation. Thus, extension of STA is warranted. As requested, the STA is modified to specify the current mode of operation, based on the information provided.

¹ KSJX is licensed for operation on 1500 kHz with 10 kilowatts daytime and 5 kilowatts nighttime, employing different directional antenna patterns daytime and nighttime (DA-2-U).

Accordingly, the request for modification and extension of STA IS HEREBY GRANTED. Station KSJX may continue to operate with parameters at variance and/or reduced power while maintaining monitor points within licensed limits. It will be necessary to further reduce power or cease operation if complaints of interference are received. MRB must notify the Commission when licensed operation is restored.² MRB must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on March 1, 2013.
