Dear Counsel:

This is in reference to the request filed August 30, 2012, on behalf of Urban Radio Communications, LLC ("URC"). URC requests further extension of the special temporary authority ("STA") granted on June 29, 2011, to operate Station WLAY from a site other than the licensed site. In support of the request, URC states that continues to seek a new site for the station.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has been prevented from restoring licensed operation due to causes beyond its control and has taken all possible steps to expeditiously resolve the problem. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WLAY may continue to operate with the following facilities:

¹ WLAY is licensed for operation on 1450 kHz with 1 kW, unlimited hours, nondirectional (ND-1-U).
