RESPONSE OF BEE BROADCASTING, INC.

This Response is timely filed by Bee Broadcasting, Inc. ("BBI"), licensee of KBBZ (FM), Kalispell, MT, to the FCC's Show Cause Order ("SCO"), dated June 22, 2011.

After the FCC's prompt release of the <u>SCO</u>, the proponent in this matter, Spanish Peaks Broadcasting, Inc. ("SPB"), filed a further amendment to its above-captioned application -- on July 12, 2011 ("Amendment") -- "abandoning" its previous (May 27, 2011) amendment, which sought both to change the proposed community of license from Charlo, MT to Woods Bay, MT and also to force the modification of BBI's license for KBBZ by an involuntary FM channel substitution. SPB's latest Amendment requests that the FCC's <u>SCO</u> "be rescinded" as "moot." <u>See</u> Amendment at Exhibit 1. Indeed, SPB now reverts to its original proposal to construct a new FM station at Charlo, MT and has filed a corresponding new Petition for Rulemaking, proposing Ch. 296C at Charlo, MT.

Without elaboration as to the manifest lack of public interest in SPB's now-abandoned (first) amendment, which produced the <u>SCO</u>, BBI simply joins SPB in

respectfully requesting that the FCC indeed rescind, cancel and dismiss the <u>SCO</u>. BBI takes no position, at this time, regarding the merits (or lack thereof) regarding SPB's Application as now pending.
