Dear Licensees:

In accordance with procedures adopted by the Commission,¹ this letter constitutes notification to Kemp Communications, Inc. and Marvin Vosper of the filing of a minor change construction permit application (BPH-20100813BHN) by Southwest FM Broadcasting Company, Inc. ("SWB"), licensee of station KAHM(FM), Prescott, AZ. SWB's application requested the substitution of Channel 231A for Channel 270A at Salome, AZ and modification of the FM Station KVGG license accordingly.² In addition, SWB's application requested the substitution of

Channel 243A for Channel 232A at Quartzsite, AZ and modification of the FM Station KBUX, license accordingly.³

Section 316(a) of the Communications Act of 1934, as amended,⁴ permits us to modify the license or construction permit if such action is in the public interest. The Act requires that we notify the affected station of the proposed action, the public interest reasons for the action, and afford at least 30 days to respond. This procedure is now set forth in Section 1.87 of the Commission's Rules.⁵ We find that the SWB application has sufficient public interest benefits to justify the issuance of a show cause order. Furthermore, SWB states that it would reimburse Kemp Communications, Inc. and Marvin Vosper for the reasonable costs incurred in connection with the proposed channel change consistent with the *Circleville* policy.⁶

Accordingly, IT IS ORDERED, that pursuant to Section 316(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 316(a), and pursuant to Section 1.87 of the Commission's Rules, Kemp Communications, Inc. and Marvin Vosper SHALL SHOW CAUSE why their licenses SHOULD NOT BE MODIFIED to specify Channel 231A in lieu of Channel 270A and Channel 243A in lieu of 232A respectively. Kemp Communications, Inc. and Marvin Vosper may, no later than 30 days from the date of this letter, file a written statement showing with particularity why their respective licenses should not be modified as proposed in this *Order to Show Cause*. The Commission may call upon the affected licensee herein to furnish additional information. If the affected licensee raises any substantial and material questions of fact, a hearing may be required to resolve such questions of fact pursuant to Section 1.87 of the Rules. Upon review of the statements and/or additional information furnished, the Commission may grant the modification, deny the modification, or set the matter of modification for hearing. If no written statement is filed by the date referred to above, the respective licensees will be deemed to have consented to the respective modification as proposed in this *Order to Show Cause* and their licenses will be reissued indicating the modification of its assignment by specifying the new channel.


