Dear Counsel:

This is in reference to the request filed January 14, 2013, on behalf of Greenup County Broadcasting, Inc. ("GCB"). GCB requests an extension of the special temporary authority ("STA") granted July 18, 2012 to operate Station WLGC-FM with reduced power.<sup>1</sup> In support of the extension request, GCB states that it has received confirmation that a new transmitter was to be shipped last week.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee is close to restoring licensed operation. Thus, a 90 day extension of the STA is warranted, which should be sufficient to allow GBC to resolve all remaining issues.

<sup>&</sup>lt;sup>1</sup> WLGC-FM is licensed for operation on Channel 289C3 (105.7 MHz) with effective radiated power of 12.5 kilowatts (H&V) and antenna height above average terrain of 142 meters.

In view of the above, the request for extension of STA IS HEREBY GRANTED. Station WLGC-FM may continue to operate with reduced power, pending a return to licensed operations. GBC must notify the Commission upon WLGC-FM's return to licensed operations. GBC must continue to use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on April 22, 2013.
