Dear Applicant:

Within 30 days from the date of this letter, file an amendment to resolve the deficiency that was discovered during the initial review of your four applications referenced above. Amendments must be filed electronically. Failure to amend your applications will result in the dismissal of the applications.

Specifically, the applications as referenced above propose a tower height increase of 3.2 meters.

Our review of the following exhibit filed with each application, as imported below, indicates no proposed tower increase to the structure as underlined.

Exhibit 14 Description: EXHIBIT 12 - ENVIRONMENTAL IMPACT STATEMENT

THE PROPOSED ANTENNA SITE IS AN EXHISTING REGISTERED TOWER. THE OVERALL HEIGHT ABOVE GROUND OF THE EXISTING STRUCTURE WILL NOT BE INCREASED, SO THERE WILL BE NO ENVIRONMENTAL IMPACT BASED ON CONSTRUCTION. CALCULATIONS SHOW THAT ELECTROMAGNETIC ENERGY AT 2 METERS ABOVE GROUND WILL NOT EXCEED 5% OF THE FCC LIMIT FOR UNCONTROLLED ENVIRONMENTS; ACCORDINGLY, NO FURTHER ANALYSIS OF RF EXPOSURE IS REQUIRED.

However, the Overall Tower Height Above Ground Level of the four proposed construction permits is 94.5 meters; and the antenna registration search results of ASRN number 1260109 as indicated in the above referenced four construction permits shows the Overall Tower Height Above Ground Level is 91.3 meters which equals a proposed tower height increase of 3.2 meters which will require notification and new tower registration with the FAA.
