
Dear Ms. Dortch:

On March 25, 2008, the renewal applications of Media General Communications Holdings, LLC, a wholly owned subsidiary of Media General, Inc. ("Media General"), for television stations WJHL-TV, Johnson City, Tennessee, WBTW(TV), Florence, South Carolina, and WRBL(TV), Columbus, Georgia, were granted by the Commission's Media Bureau. Subsequently, Free Press and NAACP filed an Application for Review of the renewal grants, which Media General opposed. Free Press *et al.* filed a Reply, and the matter remains pending.

On May 24, 2012 Media General consummated transactions pursuant to which Berkshire Hathaway, Inc. made a financial investment in Media General coupled with board representation rights and thereafter, on June 25, 2012, Berkshire Hathaway, Inc. purchased most of Media General's newspapers. As a result of these transactions, the newspaper/broadcast cross-ownerships at issue in the above noted markets remain although significantly diminished. The relevant documents have been filed with the FCC pursuant to 47 CFR Section 73.3613.

This notice is being submitted via this letter as the Commission's electronic filing protocols do not permit the electronic amendment of previously granted applications (*see attached*).
