This is in reference to the request filed February 19, 2013, on behalf of Radio Vision Cristiana Management ("RVCN"). RVCN requests further extension of the special temporary authority ("STA") originally granted on November 2, 2009 and last extended on August 20, 2012, to operate Station WVZN with temporary facilities.<sup>1</sup> In support of the request, RVCN states that since October 2011, WVZN has been diligently seeking a new transmitter site so that it could resume full operating power at a permanent regular facility. It thought that it had found such a site in early 2012, and it filed a request for FAA no-hazard approval for a two-tower array. That request was denied on May 21, 2012 and WVZN filed a request on August 6, 2012 for the FAA to reconsider its decision. Not having heard from the FAA, on December 31, 2012, WVZN requested a status report and was informed on January 2, 2013 that the FAA had done further study and had concluded that if the antenna towers are not reduced or relocated the proposal will warrant hazard determinations from the FAA. On January 11, 2013, WVZN proposed an alternative site. the FAA has not yet responded to this proposal, and a final determination has not yet been issued. WVZN is hoping for favorable action. If that fails, it will need to find another site.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration

of licensed operation; or

- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WVZN may continue to operate with temporary facilities as in previous STA. It will be necessary to further reduce power or cease operation if complaints of interference are received. RVCM must notify the Commission when licensed operation is restored.<sup>2</sup> RVCM must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **August 20, 2013**.
