Dear Licensee:

This is with respect to the letters dated February 10, 2012 and March 12, 2013 from the Video Division to Abilene Christian University ("Abilene Christian"), the licensee of Class A television station K07UF, Abilene, Texas (the "Station") regarding the Station's apparent multiple deficiencies in complying with the Commission's Rules and the requirements of Class A licensure. Scanned copies of the letters can be viewed in the station's correspondence folder in the Commission's Broadcast Radio & Television Electronic Filing System (CDBS) at http://licensing.fcc.gov/cgibin/ws.exe/prod/cdbs/pubacc/prod/corrp_list.pl?Facility_id=298.

As explained in our February 10, 2012 letter, Commission records indicate that the required Form 398 electronic filings for the station have not been made since 2001, with the exception of the first quarter of 2012. Our February 10, 2012 letter required Abilene Christian to provide information, supported by the declaration of a person with personal knowledge, identifying the quarters from 2001 through the present for which reports were prepared and placed in the station's public file and the location of the public file. The letter further required that this information be filed within 30 days and stated that failure to provide the requested information or to notify the staff that Abilene Christian was electing to let station K07UF revert to low power television status would result in the institution of a forfeiture proceeding and/or loss of Class A television status. We received a March 15, 2012 email from James Thompson of the Station requesting further guidance on this requirement. As explained in our March 12, 2013 letter, Commission records indicate that your station has failed to upload to the Commission's website its required issues/programs lists and the required documentation sufficient to demonstrate that the Class A station is continuing to meet its Class A eligibility requirements. The letter required the Station to file this information or provide an explanation why it had not within 10 days and stated that the failure to do so would result in the institution of a forfeiture proceeding and/or the loss of Class A television status.

¹ Commission records also indicate that the Station's application for license renewal (FCC File No. BRTVA-20060525ABL remains pending due to the Station's failure to file reports from 2001 through 2006.

As of today, the Station has not complied with the requests in either letter. Failure to respond to these requests within 30 days from the date of this letter will result in a change of the station's status from Class A television to low power television status.
