Dear Mr. Weiss:

This is in reference to the request filed on March 13, 2013. URC requests further extension of the STA granted on June 29, 2011, to operate Station WLAY from a site other than the licensed site.¹ In support of the request, URC states that it continues to search for a new acceptable permanent site.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WLAY may continue to operate with the following facilities:

¹ WLAY is licensed for operation on 1450 kHz with 1 kW, using an unlimited hours non-directional antenna.

It will be necessary to reduce power or cease operation if complaints of interference are received. URC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310. Failure to file an FCC Form 301 application for construction permit for a new permanent site (using an existing or new tower) before the expiration date shown below may lead to a denial of any further request for STA.

This authority expires on October 9, 2013.
