Dear Mr. Hensley:

This is in reference to the request filed on April 2, 2013. ICRC requests further extension of the STA originally granted on September 2, 1999, and modified on September 16, 2002, to operate from a site other than the licensed site, with reduced power and employing a temporary, nondirectional antenna. In support of the request, ICRC states that it has been unable to locate a suitable site (in order to file an FCC Form 301 application for construction permit to modify the licensed facility).

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that ICRC did not provide any new information to explain why an FCC Form 301 application was not filed. As a result, we will grant this extension, but no further requests for extension will be considered until after an acceptable FCC Form 301 application has been filed. Accordingly, the request for STA IS HEREBY GRANTED. Station WRFM may

It will be necessary to further reduce power or cease operation if complaints of interference are received. ICRC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310. Failure to file an acceptable FCC Form 301 application before the expiration date shown below will result in a denial of any future extension request and cancellation of the original STA.

This authority expires on July 25, 2013.
