Dear licensee:

Kremling Enterprises, Inc. ("Kremling") is hereby notified of a modification of license (BLH-19900301KA) for KYKM(FM), Yoakum, Texas to specify Channel 232A.

On September 27, 2012 Edwards Broadcasting Co. ("Edwards"), licensee of proposed station at Markham, TX filed a minor change construction permit application (BMPH-20120927ANH)¹ requesting the substitution of Channel 232A for Channel 223A at Yoakum, TX and the modification of the above captioned license.² Section 316(a) of the Communications Act of 1934, as amended,³ permits us to modify the license or construction permit if such action is in the public interest. The Act requires that we notify the affected station of the proposed action, the public interest reasons for the action, and afford at least 30 days to respond. However, on March 12, 2013, Kremling voluntarily filed a minor change application (BPH-20130312ABS) proposing operation on Channel 232A, thus consenting to the channel substitution. Furthermore, Edwards states that it would reimburse Kremling for reasonable costs incurred in connection with the proposed channel change consistent with the *Circleville* policy.⁴

Accordingly, pursuant to the authority found in 47 U.S.C. Sections 4(i), 5(c) (1), 303(g) and (r) and 307(b) and 47 C.F.R. Sections 0.61, 0.204(b) and 0.283, IT IS ORDERED, That effective the date of this letter, the FM assignment IS MODIFIED as follows:

Pursuant to Section 316(a) of the Communications Act of 1934, as amended, license BLH-19900301KA IS MODIFIED to specify operation on Channel 232A in lieu of Channel 223A.

Upon grant of the construction permit, BPH-20130312ABS, program tests may be conducted in accordance with Section 73.1620 of the Commission's Rules. Nothing contained herein shall be construed to authorize a change in transmitter location or to avoid the necessity of filing an environmental assessment pursuant to Section 1.1307 of the Commission's Rules.
