Dear Applicant:

This letter refers to the above-captioned application for a minor modification to construction permit.

Pursuant to Section 17.4(a) of the Commission's Rules,<sup>1</sup> any proposed construction of a new antenna structure or proposed alteration of an existing antenna structure that requires notification to the Federal Aviation Administration (FAA) requires registration with the Commission prior to construction or alteration. The application indicates that notification has been filed with the FAA, but there has been no substantial progress toward obtaining the required registration number. The original intent was to extend the height of the antenna structure which required reregistration. Most recently, the applicant has indicated that it will not extend the tower height and intends to mount the antenna on the existing structure.

Initially, on April 16, 2012, the staff requested status on antenna structure registration and updates of progress or delays in securing tower registration. Follow-up, status requests were made four more times requesting progress updates or an amendment providing antenna structure registration or antenna height and structure overall height correction. On May 2, 2013 a status request was made in addition to advising of this final opportunity to provide the requested amendment to the application or face dismissal of the application for failure to prosecute.

However, as of the date of this letter, fourteen months have passed since the initial request and the proposed tower has neither been re-registered nor have the amended heights on the existing tower been received. Multiple status requests by the staff have failed to produce any action on behalf of the applicant that would result in correction of the grantablility defects of the application.

Therefore in light of the above, application BMPED-20120323ACN is unacceptable for filing pursuant to 47 C.F.R. § 73.3568(a)(1) and is HEREBY DISMISSED for failure to prosecute. This action is taken pursuant to 47 C.F.R. § 0.283.
