This letter refers to the above-captioned application for W296BB, Jonesboro, Georgia.


An engineering study of the application reveals that it is in violation of 47 C.F.R. § 74.1204(a) with respect to WTSH-FM (BPH-20130412ABN), Aragon, Georgia. Section 74.1204(a) states that an application for an FM translator station will not be accepted if the proposed operation would involve prohibited overlap of predicted field strength contours with any other authorized station. Specifically, the proposed interfering contour (40 dBu) would overlap the protected contour (60 dBu) of WTSH-FM. Therefore the application will be dismissed.

In light of the above, the application BPFT-20130411ACR filed by Woman's World Broadcasting, Inc., is unacceptable for filing pursuant to 47 C.F.R. § 73.3566(a) and IS HEREBY DISMISSED. This action is taken pursuant to 47 C.F.R. § 0.283.
