Dear Counsel:

This is in reference to the request June 19, 2013, on behalf of Streetsboro City School District ("School District"). The School District requests special temporary authority ("STA") to operate Station WSTB with reduced power.<sup>1</sup> The School District reports that since the station's transmitter failed on May 23, 2013, WSTB has been operating at about 380 watts (0.38 kW) ERP. A new transmitter is expected in July.

Section 73.1560(d), which governs reduced power operation, states:

In the event it becomes technically impossible to operate at authorized power, a broadcast station may operate at reduced power for a period of not more than 30 days without specific authority from the FCC. If operation at reduced power will exceed 10 consecutive days, notification must be made to the FCC in Washington, DC, Attention: Audio Division (radio) or Video Division (television), Media Bureau, not later than the 10th day of the lower power operation. In the event that normal power is restored within the 30 day period, the licensee must notify the FCC of the date that normal operation was restored. If causes beyond the control of the licensee prevent restoration of the authorized power within 30 days, a request for Special Temporary Authority (see Section 73.1635) must be made to the FCC in Washington, DC for additional time as may be necessary.

Our review indicates that the request complies with Section 73.1560(d).



<sup>1</sup> WSTB is licensed for operation on Channel 205A (88.9 MHz) with an effective radiated power of 0.68 kilowatts (H&V) and an antenna height above average terrain (HAAT) of 112 meters.

Accordingly, the request for STA IS HEREBY GRANTED. Station WSTB may continue to operate with reduced power. The School District must notify the Commission when licensed operation is restored. The School District must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **September 27, 2013**.
