

Pocatello in its Petition for Reconsideration stated that it commenced digital broadcasting prior to the curtailment of analog operations but it had inadvertently failed to file a license application due to a change of counsel. In its Petition for Reconsideration it was represented that digital operations commenced on June 11, 2009.²

It is urged that the Commission reverse the draconian cancellation of the KPIF license and permit Pocatello to submit a license application. Attached to the instant submission is documentation supporting the fact that equipment had been ordered for the digital upgrade. This equipment was ordered well in advance of the analog cessation date. *See* Attachment D. In addition, also included in Attachment D is a copy of a check in the amount of \$84,000, in payment of Axcera invoice No. 11050-1. Furthermore, also attached is an e-mail from Nick Davidson of Oregon Trail Broadcasting to Kevin Bae confirming the installation (Attachment E).

In WKLC, Inc., DA 12-1428, the licensee was given a forfeiture for failing to timely file its license application (the license application was filed approximately four (4) years after the construction permit had expired). The licensee explained that it had in fact completed construction and began operating the station pursuant to program test authority before the permit expired. The licensee argued that it had failed to file the license application predicated on inadvertence. *See also Clear Channel Broadcasting, Inc., Memorandum Opinion and Order*, 26 FCC Rcd 7153 (2011) (“Clear Channel II”), aff’ing *Clear Channel Broadcasting, Inc., Memorandum Opinion and Order*, 21 FCC Rcd 8677 (MB) 2006) (Clear Channel I). Pocatello acknowledges that the cases cited deal with radio as opposed to television. However, Pocatello submits that this is a distinction without a difference. Furthermore, the Commission is required



to treat similarly situated applicants alike. *See Melody Music v. FCC*, 345 F.2d 730 (D.C. Cir. 1965).

Conclusion

It is urged that in light of this submission the Commission reinstate the KPIF license and thus, permit Pocatello to submit a license application. The Bureau's action in terminating the Pocatello license was draconian. In this regard, the Bureau, in response to Pocatello's February 16, 2011 Petition could have articulated its concerns and requested a supplemental showing. It is unconscionable to terminate a license for a ministerial failure (i.e. not timely submitting a license application).

Dear Counsel:

This is in regard to the petition for reconsideration filed by Pocatello Channel 15, LLC (Pocatello) of our letter of February 16, 2011, cancelling Pocatello's license for KPIF(TV) and deleting its call sign.¹ That letter decision explained that we took these actions because Pocatello's license to provide an analog television service on channel 15 was terminated by statute on June 13, 2009, and that while Pocatello was granted a construction permit to flash-cut to digital operations, that construction permit expired on June 12, 2009, and Pocatello neither filed an application for a permit extension nor for a license to cover construction of a digital facility.²

Pocatello argues that it started digital broadcasting prior to the curtailment of analog operations, but that it inadvertently failed to file a license application due to a change of counsel. Pocatello proposes that as a condition to reinstatement, it should be required to file a license to cover its digital permit.

We reject Pocatello's contention that a change of counsel excuses a failure to construct and file the requisite license application prior to the expiration of the construction permit. As we pointed out in our letter, the construction permit to flash-cut to digital operations expired on June 12, 2009.³ We do not find that change of counsel constitutes compelling circumstances justifying waiver or extension of this deadline.

Second, we do not find persuasive Pocatello's assertion that it constructed the facility prior to the expiration of the construction permit. Counsel for Pocatello submits that he "has been advised



that digital operation commenced on June 11, 2009 and has been operating since that date," but does not submit any documentary evidence or affidavit to support that claim, nor does he identify who advised him of the date that digital operation commenced. In light of the insufficiency of the evidence provided, we do not find grounds to reconsider our decision to cancel the license for KPIF(TV).

ACCORDINGLY, IT IS ORDERED that the petition for reconsideration filed by Pocatello Channel 15, LLC IS DENIED.


