Dear Ms. Dortch:

WMBQ-CA Station, LLC, licensee of commercial television station WMBQ-CD, New York, New York, hereby notifies the FCC that as of August 14, 2013, the station is operating at variance from authorized parameters. Due to a failure in the station's transmitter, the station is operating at approximately 30% of authorized output power. It is expected that repairs to bring the transmitter up to authorized power level will take a few weeks.

In the event that the repair is not achieved and full authorized power not resumed within 30-days, a request for special temporary authorization to continue to operate at variance will be filed.
