This is in reference to the request filed August 20, 2013, on behalf of Radio Vision Cristiana Management ("RVCM"). RVCM requests further extension of the special temporary authority ("STA") granted on March 21, 2013, to operate Station WVZN with temporary facilities.¹ In support of the request, RVCM states that WVZN has located a new transmitter site adjacent to its current STA operation, and on March 12, 2013, the FAA granted a no-hazard determination for that site (Aeronautical Study No. 2013-AEA-468-OE), which is good until September 12, 2014. WVZN is planning to file an FCC form 301 application shortly to construct a 75-foot permanent AM tower on the site.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made progress toward restoration of licensed

operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station WVZN may continue to operate with temporary facilities as in previous STA. It will be necessary to further reduce power or cease operation if complaints of interference are received. RVCM must notify the Commission when licensed operation is restored.² RVCM must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **February 20, 2014**.
