Dear Licensee:

Brooke Communications, Inc. ("Brooke") is hereby notified of the modification of license (BLH-19981119KE) for KSKR-FM, Sutherlin, Oregon to specify Channel 265C3.

On February 10, 2012, James D. McDaniel, licensee of station KLMD(FM), Talent, Oregon, filed a minor change application (BPH-20120210AAH)¹ requesting the substitution of Channel 265C3 for Channel 266C3 at Sutherlin, OR and the modification of the above captioned license.² Section 316(a) of the Communications Act of 1934, as amended,³ permits us to modify the license or construction permit if such action is in the public interest. The Act requires that we notify the affected station of the proposed action, the public interest reasons for the action, and afford at least 30 days to respond. Accordingly, by staff letter dated June 7, 2012, Brooke was directed to show cause why its license should not be modified to specify Channel 265C3 in lieu of Channel 266C3. On July 6, 2012, Brooke filed an Opposition to Order to Show Cause and Informal Objection. However, on July 16, 2013, Brooke filed a Request for Approval of Withdrawal of Opposition to Order to Show Cause and Informal Objection. Therefore, Brooke has consented to the channel substitution.

 $^{^2}$ The license at Sutherlin, OR can be modified to specify operation on Channel 265C3 in lieu of Channel 266C3 at the station's current authorized transmitter site (BLH-19981119KE). The authorized coordinates for the license at Sutherlin, OR are 43-22-19 NL and 123-21-15 WL.

Accordingly, pursuant to the authority found in 47 U.S.C. Sections 4(i), 5(c)(1), 303(g) and (r) and 307(b) and 47 C.F.R. Sections 0.61, 0.204(b) and 0.283, IT IS ORDERED, That effective the date of this letter, the FM assignment IS MODIFIED as follows:

<u>Community</u> Sutherlin, OR <u>Channel No.</u> Add 265C3, Delete 266C3

Pursuant to Section 316(a) of the Communications Act of 1934, as amended, license BLH-19981119KE IS MODIFIED to specify operation on Channel 265C3 in lieu of Channel 266C3.

Within 30 days of the effective date of this letter, Brooke shall submit to the Commission a minor change application for construction permit (Form 301). Upon grant of the construction permit, program tests may be conducted in accordance with Section 73.1620 of the Commission's Rules. Nothing contained herein shall be construed to authorize a change in transmitter location or to avoid the necessity of filing an environmental assessment pursuant to Section 1.1307 of the Commission's Rules.
